This year, another community is recovering from the ravages of a natural disaster following Typhoon Haiyan in the Philippines. As a result, we have chosen to make our holiday donation to the International Federation of Red Cross and Red Crescent Societies in support of relief efforts in the Philippines. Volunteers and staff from the Philippines Red Cross have been in action since the storm hit, providing search and rescue support, damage assessment, and running relief operations among those most seriously affected.

# GIVING BACK DAY 2013

---

For our Giving Back Day in New York this year, the American Securities team volunteered at Concourse Village Elementary School in the South Bronx in August, providing upkeep and a colorful touch before it opened for the 2013–2014 school year (pictured left).

In China, our colleagues organized a team to take part in the Shanghai United Walkathon – A Charity Walk for Kids. They walked up to 50 kilometers and raised money for non-governmental programs for children in China.

# CONCOURSE VILLAGE ELEMENTARY SCHOOL

Seventy-five American Securities volunteers spent the day at Concourse Village Elementary School in the South Bronx to provide a facelift and ready it to welcome 300 students for the 2013-2014 school year. The group split up into smaller teams to complete a series of projects throughout the school, including packing welcome bags for families whose children attend the school, organizing the book room, gardening, and completing numerous painting projects. Armed with paint brushes, rollers, and a bright palette of colors, we tackled two Pre-K classrooms, the first-floor classroom heaters and cabinets, inspirational canvas murals to hang up around the school, and murals on the entrance door to welcome the students and on the Principal's office door.

Concourse Village Elementary School hosts Pre-K through Second grade students for 2013-2014. It replaces a failing public school that is being phased out due to poor performance, and provides a new administration and teaching foundation. Over time, it will entirely replace the failing school for Pre-K through Fifth grade.





# SHANGHAI UNITED WALKATHON

On a rainy and cold day in April, the team from American Securities' Shanghai office and an executive from one of our portfolio companies, Unifrax, took part in the Shanghai United Walkathon – A Charity Walk for Kids in Shanghai Pudong. The event was a fundraiser for non-governmental programs for children, including assistance for malnourished children in western China and children who suffered in the Ya'an earthquake. It attracted more than 2,000 participants from 400 teams, 150 of which were corporate teams. The walkathon ran 12 hours from 7:00a.m. to 7:00p.m. over 50 kilometers and raised RMB 4.29 million (approximately \$700,000).

The American Securities team raised RMB 12,470 (approximately \$2,000). In spite of the rain, everyone had a great time and two of our colleagues completed the entire 50 kilometer course!

# THE AMERICAN SECURITIES FOUNDATION

---

American Securities has a long-standing relationship with The Robin Hood Foundation, a non-profit organization that finds, funds, and creates programs and schools that generate meaningful results for families in New York's poorest neighborhoods. We often look to them for advice on local charities, given their detailed knowledge and resources to evaluate non-profit organizations.

As this report outlines, our colleagues support numerous charitable organizations through the American Securities Foundation and other means. One of our areas of focus is alleviating hunger. With more than 1,000 emergency food providers in New York City, determining which to support can be overwhelming.

Last year, The Robin Hood Foundation brought The River Fund to our attention. The River Fund is a community-based organization with the mission "to feed and empower those [they] serve to move beyond the lines of poverty." This mission encompasses both food and non-food needs of New Yorkers living near or below the poverty level. The River Fund serves residents of all five boroughs, including men, women, children, teenagers, and senior citizens.

The River Fund started as a volunteer-only organization, but had aspirations to build a full-time staff in order to increase its reach within the community. The organization was highlighted by The Robin Hood Foundation for its use of data to make better decisions and its ability to achieve peak efficiency in all that it does. The Robin Hood Foundation provided its first grant to The River Fund in July 2012 to allow the organization to fund both food distribution and begin the process of converting volunteer staff to paid staff, but there was still much work to be done.

Later in the year, the American Securities Foundation provided a grant to The River Fund to assist them with continuing to build their organization. At the same time, our Human Resources Administrator, Kris Czerniachowicz, was looking to transition back into the non-profit sector after seven years at American Securities. She was an excellent cultural fit with The River Fund and joined them as their first-ever Director of Development in January 2013. Kris quickly became the organization's "culture bearer" in terms of developing full-time staff. She is responsible for identifying and hiring staff members, leading employee benefits, and managing The River Fund's outreach to government officials. She is also developing several new programs to address youth and children's issues.

In October 2012, Hurricane Sandy devastated New York City. Because of its award-winning mobile food pantry, The River Fund was the very first responder to hard-hit areas, including The Rockaways and Coney Island, providing not only food and water, but also necessities, such as toilet paper and diapers. The River Fund went from serving 14,000 people per month just before the hurricane to 87,000 in November and December 2012 at the peak of relief efforts. This number has now stabilized at 28,000 people per month, twice the population served prior to Hurricane Sandy. The aftermath of the hurricane exposed the issue of a large population of "working poor" in New York City, a challenge that The River Fund continues to work to address.

Hurricane Sandy was not the only problem to overcome. Budgetary cuts to food stamp programs have resulted in families having only 20 days of food in a given month; further cuts anticipated in 2014 will likely reduce that number to 15 days, or less than half of the days in most months. In addition, rent increases in New York City have left many senior citizens with limited resources to cover non-housing related expenses. The River Fund has experienced surging demand, serving over 1,000 families on the Saturday before Thanksgiving at their main pantry, compared to 600 to 700 families on a "normal" Saturday. In addition, The River Fund's mobile unit serves at two sites twice a month. Because of Hurricane Sandy, The River Fund also

formed five satellite sites in the still-active flood zones. At their “Client Choice” pantry, The River Fund offers non-perishable canned goods, pasta, rice, cereal, milk, juice, fresh vegetables, meat, bread, snacks, etc. Good nutrition is paramount to the organization and procuring and providing fresh produce is key. At times depending on donations, The River Fund is also able to offer baby food, diapers, pet food, and clothing. The River Fund does not refuse anyone in its pantry line.

The River Fund is the only one-stop “shopping” location for food, benefits, and services in Queens. In addition to hunger relief, it assists community members with enrollment for food stamps and other benefits like Medicaid and public assistance. The River Fund also provides free tax-preparation assistance and advice, immigration and other legal services, HIV screening, and health care referrals and counseling.

Approximately 40% of the 160,000 beneficiaries served annually by The River Fund are children. As a result, programs geared towards this population are an important part of The River Fund’s services. It provides vitamins monthly and annual back-to-school supplies, and does an annual shoe giveaway. In the summer, The River Fund keeps at-risk youth aged 14 to 18 off the streets by enrolling them in its dual-league basketball team, The River Fund Cobras. In 2013, The River Fund partnered with The Fresh Air Fund and sent 44 needy children to both summer camp and home stays with host families. During the holidays, The River Fund distributes approximately 20,000 toys so children can enjoy holiday gifts.

American Securities is proud to support The River Fund in its efforts to respond to the needs of its community in nearly every way possible.





## OUR COLLEAGUES

---

At American Securities, our involvement in charitable organizations extends beyond the Firm's annual Giving Back Day and monetary donations. Many of our colleagues choose to devote countless hours of their time volunteering at charitable organizations. This year, Brian Sheridan and Carolyn Jander share their personal experiences with non-profit organizations that champion causes near their hearts.

**BRIAN SHERIDAN**, an Associate on American Securities' investment team, first got involved with a local Big Brothers Big Sisters (BBBS) program while in college at the University of Notre Dame. After Brian moved to New York, he sought to continue his commitment to assist underprivileged children by reaching out to the New York City chapter of BBBS.

## BIG BROTHERS BIG SISTERS

BBBS is one of the oldest and largest youth-mentoring organizations in the United States, having served over 100,000 children since its founding in 1904. The organization aims to provide children facing adversity with strong and enduring one-to-one relationships that have direct and lasting effects on their lives. This is achieved through monitored matches between adult volunteers (Bigs) and children (Littles), ages 6 through 18, in communities across the country.

Brian explains, “Growing up, I had been active with youth-coaching programs that I found to be extremely enriching experiences.” In college at Notre Dame, he was introduced to the BBBS chapter of St. Joseph’s County, Indiana, in December 2007. Brian says, “I felt that volunteering as a Big would be a great opportunity to continue the philanthropic endeavors I had enjoyed previously.”

Brian was matched with a local, underprivileged child, a relationship that spanned the four years Brian spent at Notre Dame. Brian says, “It was, and has been, a very close friendship, and being able to watch my Little grow over the years has been deeply meaningful.”

Brian explains, “I sought to continue this experience with the program in New York and became involved with BBBS of New York

City earlier this year. I have a match with a new Little and continue to be excited for another opportunity to see my Little develop and grow.” Brian’s relationship with his Little entails meeting twice a month for four to six hours each meeting. Their activities range from social to academic, including going to the movies, playing sports in the park, and assisting his Little with homework, among other activities.

“I have seen a positive effect though the mentorship of my Littles. The children enrolled in these programs need role models, and I have been amazed by the significance that these relationships have on their and their families’ lives, as well as my own. The impact of taking time out to help has been immeasurable.”

The youth mentorship need has always been high and often unmet. BBBS’ New York City chapter receives countless applications from families and always faces a shortage of Bigs to match with these children in need. Brian concludes, “I will continue to commit time to the organization to promote higher aspirations, greater confidence, and success in and out of the classroom.”

**CAROLYN JANDER**, an Executive Assistant who supports American Securities' President & Chief Executive Officer, as well as several other colleagues, is an active volunteer in New Jersey which she calls home. She contributes her talent for and love of gardening to the New Jersey State Botanical Garden throughout the year.

### **NEW JERSEY BOTANICAL GARDEN**

The New Jersey State Botanical Garden is a part of Ringwood State Park, New Jersey Division of Parks and Forestry, Department of Environmental Protection. It appears on both the State and National Registers of Historic Places. In March 1984, Governor Thomas Kean designated the central 96 acres surrounding the manor house as the State's official botanical garden.



NJBG forms the heartland of a property that Francis Lynde Stetson assembled from pioneer farmsteads in the Ramapo Mountains. Stetson named his country estate "Skylands Farms" and maintained a stylish mansion of native granite, a working farm with more than thirty outbuildings, gardens and a vast lawn that also served as a nine-hole golf course. He was a trustee of the New York Botanical Garden and chose Samuel Parsons, Jr., a protégé of Frederick Law Olmsted, to lay out his estate.

Skylands was sold in 1922 to Clarence McKenzie Lewis, a trustee of the New York Botanical Garden. When Lewis purchased the property, he set out to make it a botanical

showplace. The Stetson house was torn down, and the current Tudor mansion was built on the site. Most of the specimen trees found in the garden today were planted under Lewis' ownership. For thirty years, Lewis collected plants from all over the world and from New Jersey roadsides. The result is one of the finest collections of plants in the state.

In 1966, New Jersey purchased 1,117 acres of Skylands from Shelton College, which at that time was using the land and buildings as its campus.

### **VOLUNTEERS, THE HEART OF THE GARDEN**

Some organizations feed the body; the New Jersey Botanical Garden feeds the soul. Without volunteers, maintaining the wonderful sights, sounds and scents of the garden would not be possible. Each year, volunteers put in hundreds of hours of their time to keep the garden beautiful and ready for visitors with minimal aid from the state. The thirteen various gardens are planted, pruned, weeded, and cleared by volunteers, many of whom have obtained Master Gardener status. While taking a stroll through the moraine garden, the lilac garden or the wildflower garden, one might not take notice of the grueling summer work that goes into the upkeep, but visitors will notice the beauty and serenity of the gardens against the backdrop of the Ramapo Mountains.

While Carolyn cannot join the gardening team on Wednesday mornings at 10:00a.m. to weed and groom due to her responsibilities at American Securities, she finds ample additional opportunities to volunteer throughout the year at NJBG. Carolyn particularly enjoys talking to garden lovers at the annual plants sale in May

and explaining to visitors how best to care for their new purchases. October brings Harvest Fest where you can find Carolyn painting pumpkins with children or helping with manor house tours. Harvest Fest is great for the whole family and children enjoy tractor rides and games while adults peruse the items for sale by local crafters.

Things do not slow down at the garden once fall arrives. Carolyn always joins the annual daffodil planting group in late October. She enjoys returning in April to see the fruits of her labor. Visitors can be continually delighted with thousands of new daffodils popping up each spring.

December is a very special time of the year as volunteers prepare for the holidays. Each year, the manor house is decorated in a different theme. The first week of December marks the holiday open house, where Carolyn guides tours and talks about the history of the house and the current theme. Last year, the theme was New Jersey birds . . . and one penguin.

The New Jersey Botanical Garden also brings much joy to many people through its summer concert series, craft fairs and woodland hikes. Carolyn is pleased to be able to contribute to the success of the garden by doing what she truly loves – gardening.

On the afternoon of May 20, 2013, an EF5 tornado, with peak winds estimated at 210 miles per hour, struck Moore, Oklahoma and adjacent areas, killing 24 people and injuring 377 others. The tornado was part of a larger weather system that had produced several other tornadoes during the previous two days. As the nation watched the aftermath of this tragic event, a local Presidio engineer, Oscar Garza, sent out a text message to the Oklahoma team asking, “What can we do?” The team collaborated, and with encouragement from senior management, was able to provide lunch to 300 volunteers at a local shelter in Norman, Oklahoma.

The Presidio team also volunteered their services for the afternoon to help load and unload supplies coming into the shelter before being dispersed back into the community. The engineering team provided many hours of volunteer efforts working hand-in-hand with the local disaster recovery team to provide wireless access to the devastated area. This in turn enabled the affected homes and businesses to provide their family, friends, and customers with much needed status updates.

Eleven days later, on May 31, 2013, another tornado struck El Reno, Oklahoma. It is believed to be the widest tornado on record in the United States at 2.6 miles across, and it caused incredible damage. This tornado and its resulting flooding claimed 18 lives, including

six children and a dozen adults. Area hospitals treated 115 injuries after the storm, according to the Oklahoma Department of Emergency Management.

The basement of Oklahoma City’s operations building was flooded and rendered uninhabitable. Unfortunately, all of their spare network equipment was located in that basement.

Presidio engineers Joel Wilson, Oscar Garza and Charlie Otis immediately jumped in and assisted the city, which was experiencing an outage due to the tornado and weather they endured. Joel and Oscar called two clients, Chesapeake and Access Midstream, to see if they would be willing to loan network equipment short term to get vital city services back online. Both graciously offered to assist. The equipment was delivered to the city IT team the next day, so they could set up temporary offices in a nearby building.

Presidio was fortunate enough to be able to assist its clients and the community at a time of need. The Oklahoma City IT Director, Jason Gipson, was very appreciative that Presidio was there when he needed help. Presidio prides itself on client service, engineering expertise, and its ability to make technology practical for business needs, but sometimes nothing is more important than being able to help its community when in need.



### **SANTA PAL**


Each year, United Central Industrial Supply and its employees have contributed to the Bristol, Virginia/Tennessee Santa Pal program. Now in its 85th year, Santa Pal encourages individuals, churches, civic groups, and businesses to provide Christmas gifts to needy families. Santa Pal was founded in 1927 by a former Bristol Herald Courier editor and is now overseen by the local United Way chapter. The program serves children from between Kindergarten and Eighth grade in both Bristols and a portion of Sullivan County. UDG “adopts” a group



of children by providing gifts and/or donating money. Monetary donations are used to purchase gift cards from major national retailers and purchases are restricted to items for children. All families are chosen through school guidance counselors, based on their economic status. The program serves approximately 400 families and nearly 700 children.

### **CROSSROADS MEDICAL MISSION**

Each year, United Central Industrial Supply partners with and monetarily supports The Crossroads Medical Mission, a non-profit Christian ministry providing primary medical services to those in southwest Virginia and northeast Tennessee who are falling through the cracks of the current health care system. Since January 2002, Crossroads has been providing primary medical services to those with difficulty accessing medical care in southwest Virginia and northeast Tennessee. The organization specifically targets those who have no ongoing source of health care, particularly the uninsured and low-income individuals. Crossroads’ medical staff includes a full-time nurse practitioner and two part-time board certified family physicians. The mission works in partnership with outreach organizations such as homeless shelters, food pantries, community centers, and churches of various denominations.
